**Terms and Conditions:**

1. Unsealed & conditional tenders shall not be accepted.
2. Bidders are required to deposit 2% of estimated cost of the work as Earnest Money (EMD) in form of Demand draft/FDR in favor of Administrative Officer, G.B. Pant Social Science Institute, Prayagraj.
3. The Institute reserves right to reject or accept any or all the tender without assigning any reason thereof or to distribute the whole work between two or more contractors/firms.
4. Rates should be valid for 30 days from the date of opening of tenders.
5. Taxes shall be deducted as per rules.
6. Your rates should be inclusive of all taxes.
7. The payment of wages/ allowance and other benefits admissible including safety to persons employed by the contractor for the job shall be the sole responsibility of the contractor as their employer under law.
8. The contractor shall be legally liable and responsible for any contravention of any legal requirement and consequent liability with regard to persons deployed by him in connection with the work assigned to him by the Institute.
9. In case of any dispute the decision of the Director, G.B. Pant Social Science Institute shall be final and binding on both the parties.
10. All the litigations will be subjected to the jurisdiction of courts at Allahabad.
11. In case the work is not completed in stipulated time penalty of 5% of the value of work will be deducted from the contractors bill subject to maximum of 10% of total amount of bill.
12. Statutory deductions as per rule will be made from the bill.
13. Work will be carried out as per standard specification CPWD/PWD/BIS etc & good practices of construction/maintenance.
14. Defect liability period for the work will be 12 months from the date of completion of the work.
15. The bidder shall sign all the pages of tender document.
16. The bidder will submit requisite no. of the photographs of the site before starting of the work and after completing of the work, in case the work is awarded to the bidder.
17. Any damage/loss to the Institute property during the work/job will be borne by the firm and shall be deducted from the final bill.
